## Instructors

**William J. Zaorski**, Deputy Attorney General (retired) served over 30 years in governmental service. He was an instructor of search & seizure and related criminal justice topics. He developed specialty training courses for law enforcement officers on the Anatomy of a Search Warrant Affidavit, Street Encounters of All Kinds, Legal Aspects of Interrogation 201, Legal Aspects of Use of Force, Investigating a Domestic Violence Case and others. He is currently the Director of Legal and Police Studies for Career Development Institute, Kendall Park, N.J., he conducts training programs on search and seizure and related criminal justice subjects for Animal Cruelty Investigators and SPCA Humane Law Enforcement Officers. He is a graduate of Seton Hall Law School and is a member of the NJ State Bar, he serves as a member of the animal law subcommittee. He attended the Federal Bureau of Investigation (FBI) National Law Institute. He is a member of the Association of Prosecuting Attorneys, the National District Attorneys Association, the International Society for Technology in Education, the International Law Enforcement Educators and Trainers Association.
